



EXPRESS TAGGING/EARLY DROP OFF
Consignor Agreement
 This is a binding agreement between Fairytale Threads, LLC and the Consignor listed below.

As an Express Tagging consignor, you will earn a commission rate based on the option you choose below. This percentage is firm, and no additional percentage can be earned by working a volunteer shift. Once dropped off, you have given Fairytale Threads, LLC your permission to price the items as they see fit. Any items Fairytale Threads, LLC does not see fit for this sale, will be held for you to pick up at an agreed upon time before the sale (unless you have checked the donate box at the bottom of this page). Items not picked up within 3 days of being notified will be donated.

- Once you have registered and paid the \$10 consignment fee through the Fairytale Threads website, you will be eligible to schedule a drop off time with a team member. The remainder of your consignment fee, based on the option you choose and amount of items dropped off, will be deducted from your commission check.
- All items will be prepared and priced to sell by our expert consignors. Our goal is to get you the biggest check!
- Please provide enough hangers for clothes, batteries for toy or bags for parts. If you do not have enough, they will be provided for you at the following cost, taken from your final check: Hangers= \$.10 each. Batteries = \$1to \$2 each battery, small bags = \$.25 each, large bags = \$.50 each, jumbo bags = \$1 each, XL bags= \$2.50 each.
- Infant sized clothes (newborn-6 months) will be limited to boutique brands, Janie & Jack, Gymboree, Hanna Anderson and other upscale brands. Carters, Target, Walmart and Old Navy type brands will not be accepted for tagging service due to the large amount of clothing in these sizes.
- When dropping off items, please deliver items in disposable boxes that close.
- Fairytale Threads, LLC is not responsible for any items that are or subject to a manufacturer's recall. It is the consignor's responsibility to check to see if items they consigned are on the government issued recall list.
- Fairytale Threads, LLC reserves the right to decline any item for any reason. **Taggers have strict standards, set by Fairytale Threads, that they must follow.** This will help keep our sale "upscale" and desirable for our shoppers. All sales are final.
- All items will be discounted. If requested, a few items can be kept at full price.
- You will be able to shop the Consignor Presale on Wednesday, March 14 at 5:30pm!

You must be signed up as an Express Consignor by 3/17/18 and items must be dropped off no later than 2/26/18. Spots might fill up before those dates so please contact us ASAP to save your spot!

All unsold items must be picked up by the consignor, or a specified person, on Saturday, March 17, 2018, between 6:00-7:30pm or donated. A responsible party, assigned by the consignor to pick up their items must bring a drivers license or state issued ID for identification purposes. **Any items left after 8pm on Saturday, March 17, 2018 will be donated.** Consignors agree to not hold Fairytale Threads, LLC, its owners, operators, event staff, volunteers or venue personally liable for any reason, including damage of consigned items, theft, loss, vandalism, fire or natural disaster.

OPTION A-"Hung and Sorted" EXPRESS TAGGER

CONSIGNOR RESPONSIBILITIES AND EARNINGS:

- **Drops off clean items to Fairytale Threads Team** Member with all clothing items hung on plastic hangers (child size for newborn-5t), and in disposable boxes that close. All clothing must be sorted by size and gender. (All girls 3's together, all Medium's together, etc.)
 - All toys and other items with pieces and parts in baggies and attached so they will not be lost. All battery operated items must have working batteries.
 - All shoes must be zip tied together.
 - All dropped off items must be SALE -READY to receive full commission.
 - Consignor must register online as a consignor and pay the \$10 traditional Consignor fee.
 - Consignor receives **50%** Commission
 - Consignor receives 2 presale passes for the consignor presale
 - Consignor picks up unsold items on Saturday 9/16/17 between 6pm-7:30pm or allows them to be donated after 8pm.
 - Additional fees will be taken off profit check, \$20 for first 200 items dropped off and \$5 more per each 50 items.
For example: 1-200 items:\$20 fee, 201-250 items:\$25 fee, 251-300 items:\$30 fee, 301- 351 items:\$35 fee
- EXPRESS TAGGING TEAM MEMBER** Is responsible for pricing, entering, tagging, storing and dropping off all items to the sale venue.

OPTION B-"Sorted" EXPRESS TAGGER

CONSIGNOR RESPONSIBILITIES AND EARNINGS:

- **Drops off clean items to Fairytale Threads Team Member** with all clothing sorted by size and gender. (All girls 3's together, all Medium's together, etc.)
 - All toys and other items with pieces and parts in baggies and attached so they will not be lost. All battery operated items must have working batteries.
 - All shoes must be zip tied together.
 - All dropped off items must be SALE -READY to receive full commission.
 - Consignor must register online as a consignor and pay the \$10 traditional Consignor fee.
 - Consignor receives **40%** Commission
 - Consignor receives 2 presale passes for the consignor presale
 - Consignor picks up unsold items on Saturday 9/16/17 between 6pm-7:30pm or allows them to be donated after 8pm.
 - Additional fees will be taken off profit check, \$20 for first 200 items dropped off and \$5 more per each 50 items.
For example: 1-200 items:\$20 fee, 201-250 items:\$25 fee, 251-300 items:\$30 fee, 301- 351 items:\$35 fee

OPTION C-"Drop and Run" EXPRESS TAGGER

CONSIGNOR RESPONSIBILITIES AND EARNINGS:

- **Drops off clean items to Fairytale Threads Team Member**
- All toys and other items with pieces and parts in baggies and attached so they will not be lost. All battery operated items must have working batteries.
- All dropped off items must be Clean to receive full commission.
- Consignor must register online as a consignor and pay the \$10 traditional Consignor fee.
- Consignor receives **25%** Commission
- Consignor receives 2 presale passes for the consignor presale
- Consignor picks up unsold items on Saturday 9/16/17 between 6pm-7:30pm or allows them to be donated after 8pm.
- Additional fees will be taken off profit check, \$20 for first 200 items dropped off and \$5 more per each 50 items.
For example: 1-200 items:\$20 fee, 201-250 items:\$25 fee, 251-300 items:\$30 fee, 301- 351 items:\$35 fee

EXPRESS TAGGING TEAM MEMBER Is responsible for hanging items, pricing, entering, tagging, storing and dropping off all items to the sale venue.
